The school registered nurse (RN) is responsible for nursing care provided to individual students as outlined in ODE guidance and state law: <ul style="list-style-type: none"> <li>• Communicate with parents and health care providers to determine return to school status and current needs of the student.</li> <li>• Coordinate and update other health services the student may be receiving in addition to nursing services. ### 1f. ENTRY AND SCREENING

<p>Direct students and staff to stay home if they, or anyone in their homes or community living spaces, have COVID-19 symptoms, or if anyone in their home or community living spaces has COVID-19.</p> <p>COVID-19 symptoms are as follows:</p> <ul style="list-style-type: none"> <li>Primary symptoms of concern: cough, fever or chills, shortness of breath, or difficulty breathing.</li> <li>Note that muscle pain, headache, sore throat, new loss of taste or smell, diarrhea, nausea, vomiting, nasal congestion, and runny nose are also symptoms often associated with COVID-19. More information about COVID-19 symptoms is available <a href="https://www.cdc.gov/coronavirus/2019-ncov/symptoms-testing/symptoms.html">from HYPERLINK "https://www.cdc.gov/coronavirus/2019-ncov/symptoms-testing/symptoms.html"</a> CDC.</li> <li>In addition to COVID-19 symptoms, students should be excluded from school for signs of other infectious diseases, per existing school policy and protocols. See pages 9-12 of <a href="#">OHA/ODE Communicable Disease Guidance</a>.</li> <li>Emergency signs that require immediate medical attention: <ul style="list-style-type: none"> <li>Trouble breathing</li> <li>Persistent pain or pressure in the chest</li> <li>New confusion or inability to awaken</li> <li>Bluish lips or face</li> <li>Other severe symptoms</li> </ul> </li> </ul>	<p><b>Screening Students:</b> All classes with outside doors will utilize this entrance; the classroom teacher will conduct a visual screen for the appearance of symptoms.</p> <p>Classes in main building will enter as directed below: Preschool--- enter through west doorway at end of hall Kindergarten—enter through front doors by office 3<sup>rd</sup>/4<sup>th</sup> ----enter through main doors of Church 1<sup>st</sup>—enter through media entrance</p> <p>Classes in the main building will have a staff member greet them at their respective entrance, and conduct a visual screen for the appearance of symptoms. The classroom teacher will repeat this screen at the door to the classroom.</p> <p>When screening indicates that a student may be symptomatic, the student is directed to the Office where they will be supervised by staff until parents can pick them up in the designated isolation area. Student will be given a facial covering, and staff should also wear a facial covering and maintain physical distancing.</p>

<p>Screen all students and staff for symptoms on entry to bus/school every day. This can be done visually and/or with confirmation from a parent/caregiver/guardian.</p> <ul style="list-style-type: none"> <li>• Anyone displaying or reporting the primary symptoms of concern must be isolated (see section 1i of the <b>Ready Schools, Safe Learners</b> guidance) and sent home as soon as possible.</li> <li>• They must remain home until 72 hours after fever is gone (without use of fever reducing medicine) and other symptoms are improving.</li> </ul>	<p>Handwashing stations or hand-sanitizers will be placed by each entrance prior to student entrance.</p> <p><b>Screening Staff:</b> Staff are required to report when they may have been exposed to COVID-19.</p> <p>Staff are required to report when they have symptoms related to COVID-19.</p>
<p>Follow LPHA advice on restricting from school any student or staff known to have been exposed (e.g., by a household member) to COVID-19 within the preceding 14 calendar days.</p>	<p>Staff members are not responsible for screening other staff members for symptoms.</p>
<p>Staff or students with a chronic or baseline cough that has worsened or is not well-controlled with medication should be excluded from school. Do not exclude staff or students who have other symptoms that are chronic or baseline symptoms (e.g., asthma, allergies, etc.) from school.</p>	<p><b>Ongoing:</b> Weekly note reminding parents to report actual symptoms when calling students in sick as part of communicable disease surveillance. Any student or staff member known to have been exposed (e.g., by household member) to COVID-19 shall not be allowed on campus until the passage of 14 calendar days after exposure and until symptoms (e.g., fever, cough, shortness of breath, sore throat, headache) are improving.</p>
<p>Hand hygiene on entry to school every day: wash with soap and water for 20 seconds or use an alcohol-based hand sanitizer with 60-95% alcohol.</p>	<p><b>Do not exclude staff or students who have a cough that is not a new onset or worsening cough (e.g., asthma, allergies, etc.) from school.</b></p> <p>Parents/guardians can provide information regarding existing conditions that cause coughing to be utilized for the purpose of screening, as previously existing coughs that are not worsening are not considered symptomatic of COVID-19.</p>

**1g. VISITORS/VOLUNTEERS**

OHA/ODE Requirements	Hybrid/Onsite Plan
<p>Restrict non-essential visitors. Only allow visitors if six feet of physical distance between all people can be maintained.</p>	<p><b>Visitors/Volunteers:</b> Will be unable to work in the school, or complete other volunteer activities that require in person interaction, at this time. Adults in school will be limited to essential personnel only.</p>
<p>Visitors must wash or sanitize their hands upon entry and exit.</p>	
<p>Visitors must wear face coverings in accordance with OHA and <a href="#">CDC</a> guidelines.</p>	
<p>Screen all visitors for symptoms upon every entry. Restrict from school property any visitor known to have been exposed to COVID-19 within the preceding 14 calendar days.</p>	

**1h. FACE COVERINGS, FACE SHIELDS, AND CLEAR PLASTIC BARRIERS**

<p>Face coverings or face shields for:</p>	

<ul style="list-style-type: none"> <li>Staff who are regularly within six feet of students and/or staff <ul style="list-style-type: none"> <li>This can include staff who support personal care, feeding, or instruction requiring direct physical contact.</li> <li>Staff who will sustain close contact and interactions with students.</li> </ul> </li> <li>Bus drivers.</li> <li>Staff preparing and/or serving meals.</li> </ul>	<p><b>Facial Shields:</b> Will be required and provided for the Speech/Language pathologist and front office staff.</p> <p>Facial coverings are strongly encouraged for the Music teacher, PE teacher, and Reading teacher.</p> <p>Facial coverings are recommended for all staff.</p>
<p>Face shields, face coverings or clear plastic barriers for:</p> <ul style="list-style-type: none"> <li>Speech Language Pathologists, Speech Language Pathology Assistants, or other adults providing articulation therapy.</li> <li>Front office staff.</li> </ul>	<p>Facial coverings are not recommended for children under the age of 12.</p> <p>Children of any age should not wear a face covering:</p> <ul style="list-style-type: none"> <li>If they have a medical condition that makes it difficult for them to breathe.</li> <li>If they experience a disability that prevents them from wearing a face covering.</li> <li>They are unable to remove the face covering independently, or</li> <li>While sleeping.</li> </ul>
<p>Face masks for school RNs or other medical personnel when providing direct contact care and monitoring of staff/students displaying symptoms. School nurses should also wear appropriate Personal Protective Equipment (PPE) for their role.</p>	<ul style="list-style-type: none"> <li>If they have a medical condition that makes it difficult for them to breathe.</li> <li>If they experience a disability that prevents them from wearing a face covering.</li> <li>They are unable to remove the face covering independently, or</li> <li>While sleeping.</li> </ul>
<p><b>Students who choose not to wear face coverings must be provided access to instruction.</b></p>	
<p><b>ADA accommodations:</b> If a staff member requires an accommodation for the face covering or face shield requirements, districts and schools should work to limit the staff member’s proximity to students and staff to the extent possible to minimize the possibility of exposure.</p>	<p><b>Face coverings cannot be required for use by children and should never prohibit or prevent access to instruction.</b></p>

**1i. ISOLATION MEASURES**

OHA/ODE Requirements	Hybrid/Onsite Plan
<p>Protocols for surveillance COVID-19 testing of students and staff, as well as exclusion and isolation protocols for sick students and staff whether identified at the time of bus pick-up, arrival to school, or at any time during the school day.</p>	<p>The Principal will connect weekly with school nurse on updates for plan and isolation measures taken to that point.</p>
<p>Protocols for assessment of students, as well as exclusion and isolation protocols for sick students and staff identified at the time of arrival or during the school day.</p> <ul style="list-style-type: none"> <li>Work with school nurses, health care providers, or other staff with expertise to determine necessary modifications to areas where staff/students will be isolated.</li> <li>Consider required physical arrangements to reduce risk of disease transmission.</li> <li>Plan for the needs of generally well students who need medication or routine treatment, as well as students who may show signs of illness.</li> </ul>	<p>All students who become ill at school with excludable symptoms will remain at school supervised by staff until parents can pick them up in the designated isolation area. Students will be provided with a facial covering (if they can safely wear one). Staff should wear a facial covering and maintain physical distancing, but never leave a child unattended.</p> <p>While exercising caution to ensure safety is appropriate when working with children exhibiting symptoms, it is also critical that staff maintain sufficient composure and disposition so as not to unduly worry a student or family.</p>
<p>Students and staff who report or develop symptoms must be isolated in a designated isolation area in the school, with adequate space and staff supervision and symptom monitoring by a school nurse, other school-based health care provider or school staff until they are able to go home. Anyone providing supervision and symptom monitoring must wear appropriate face covering or face shields.</p> <ul style="list-style-type: none"> <li>School nurse and health staff in close contact with symptomatic individuals (less than six feet) should wear a medical-grade face mask. Other Personal Protective Equipment (PPE) may be needed depending on symptoms and care provided.
